2. Save the date for Wednesday, February 7th for the event “Sex Rules” with CASE in the Laird Room. The event is about issues around relationships and interpersonal violence.
3. Gave a handout concerning sexual misconduct cases response analysis. This attempts to measure the response to reports by the Dean of Students Office and student participation and response. Some cases go nowhere, some receive an intake offer which may or may not be accepted or responded to. This attempts to measure all the different results and options of cases and what route students take and how the Dean of Students office responds.
- ii. President Koenig asks what the different supportive measures mean such as advocacy.
 1. DOS Seppelt gave a summary of each.
 - a. Counseling is connecting students to therapy.
 - b. Advocacy is students having the choice advocates attending meetings.
 - c. Housing means requiring housing and residence life to make a change such as a room change.
 - d. Academics means sending notes of support to faculty to assist student academics such as class changes.
 - e. No contact means putting a no contact order in place
 - f. Location restriction means banning someone from somewhere.
 - g. Law enforcement is assisting with reports to police.
 - h. Tuition is rare but involves paying for school if the case impacted the student’s academics extremely.
 - i. Employment involves those whose case impacts a job and needs assistance to safely continue employment.
- iii. Senator Zdrodowski asked to see an example of an intake offer. Concerned with the possibility of it being off-putting and resulting in lower response rates in cases.
 1. DOS Seppelt says it is possible to get an example, but it is naturally off-putting getting contact about these cases from the university. The DOS office makes sure to always invite twice with the second time involving less information to help it appear less intimidating and offer better support.
