- 3 Whereas, The Student Government Association Graphic Designer used to be a held position in
- 4 the Executive Branch;
- 5 Whereas, The SGA Graphic Designer made social media posts and aided the SGA
- 6 Communications and Public Relations Director;
- 7 Whereas, SGA has not had a SGA Graphic Designer in over a session;
- 8 Whereas, The SGA Graphic Designer has similar responsibilities to the Communications and
- 9 Public Relations Director;
- 10 Whereas, In the absence of the SGA Graphic Designer, the SGA Communications and Public
- 11 Relations Director has taken on their responsibilities;
- 12 Therefore, be it resolved, The SGA Graphic Designer shall be struck from the SGA Bylaws and
- 13 SGA Constitution;
- 14 Therefore, be it further resolved, The Communications and Public Relations Director Position
- 15 Bylaws shall absorb the SGA Graphic Designer responsibilities;
- 16 Therefore, be it further resolved, All reference to the SGA Graphic Designer shall be changed
- 17 to the SGA Communications and Public Relations Director;
- 18 Therefore, be it further resolved, Under Article XXVI, section 5. shall read;

- 40 O. Serve a minimum of 10 hours per week in the SGA Office or related work meeting on
- 41 campus, with the exception of Student Senate.
- 42 P. Meet at a minimum of once near the end of each semester with the Executive Director to
- 43 specifically discuss and document transitional material including semester accomplishments and
- helpful tips. Documentation must be typed, emailed, and stored in the Student Government
- 45 Association email account, as well as handed over for the next person in the role. Transitional
- 46 materials must also include an updated list of contacts at the last meeting of the executive's term.
