Resolution Amending the Pointers After Dark Bylaws

Whereas, the Constitutional Review Committee over sees the amending of all bylaws of the Student Government Association;

Whereas, The Pointers After Dark Committee was expressed interests and wrote amendments to the Pointers After Dark Bylaws;

Whereas, This resolution is to reorganize leadership of the committee, clarify funding, and provide clearer direction for the Pointers After Dark Committee;

Therefore be it Resolved, Article III section c. be removed in its entirety

Therefore be it further Resolved, Article IV, shall read;

Article IV – Membership

- i. The Pointers After Dark (PAD) Committee shall be composed of the following voting members:
 - a. The Student Program Manager of CASE, to serve as the PAD Chairperson
 - b. Two student representatives nominated by CASE
 - c. Two student representatives nominated by SGA
 - d. Two student representatives nominated by RHA
 - e. Two student representatives nominated by DCA
- ii. The PAD shall also be composed of the following non-voting members:
 - a. One staff or professional staff member appointed by the Associate Director of CASE
 - b. SGA Advisor
 - c. RHA Advisor
 - d. One representative from the Center for Prevention
 - e. One representative from Diversity and College Access
 - f. One representative from University Dining
- iii. Membership in the PAD is open without regard to age, race, creed, religion, color, handicap, socio-economic status, national origin, ancestry, sexual orientation, or political affiliation. All student members must be in good academic standing (above GPA of 2.0).
- iv. Membership terms shall be from May 31st to May 30th of each year with the expectation of summer collaboration.;

Therefore be it further resolved, Article V section a, shall read,

- a. The Chairperson shall be the Student Program Manager from CASE

Therefore be it further resolved, Article VI, shall read,

Article VI - Budget Manager

- a. The Budget Manager shall be the SGA Travel & Financial Specialist
- b. Members of the committee shall be responsible for sending all receipts from financial transactions to the Budget Manager.
- c. The Chairperson shall connect with the Budget Manager at least once per month to review the budget.
