Resolution

Whereas, the Supreme Court of the United States of America overturned Roe v. Wade June 24th 2022, taking away federal protection for medical reproductive rights across the country.

Whereas, 15 states implemented abortion restrictions after Roe v. Wade was overturned, resulting in limited access to abortion in the case of a pregnancy

Whereas, currently, Wisconsin bans abortion past 22 weeks of gestation, with required waiting periods and parental consent for minors, and includes no exceptions for rape and incest.

Whereas, according to Harvard School of Public Health, restricting access to safe and legal abortions does not lower the abortion rates, but increases the rate of illegal, unsafe abortion practices along with death rates from these practices.

Whereas, according to Planned Parenthood, before the legalization of abortion, 17% of death related to pregnancy and childbirth were caused by unsafe abortion practices and after the Roe v. Wade decision in 1973, only 0.3% of pregnancy related deaths were caused from abortion complications.

Whereas, access to medical reproductive rights allows women to finish school, pursue higher education, and participate in the workforce at higher rates for all social classes, enabling them to reach their full potential and effectively participate within society.³

Whereas, Duke University conducted a study that estimates the pregnancy mortality rate in the case of a total abortion ban in the US, pregnancy-related deaths would increase by 7%. In the years after a ban, total deaths would increase 21% for all populations. Populations that would be most affected include Non-Hispanic Black people, who would experience a 33% increase mortality. These numbers do not include mortality estimates if unsafe practices increase due to limited access to abortion resources.

Whereas, restricting access to abortion services, according to United Nations (UN) Human Rights Chief Michelle Bachelet, is a human rights violation that contributes to gender inequality and violates the right to health that supports bodily autonomy.⁶

Whereas, the UN Committee on the Elimination of Discrimination Against Women calls for the American states to legalize abortion practices and remove punishment for people who receive the procedure.⁶

Whereas, legal and safe access to abortion reduces unwanted and underage pregnancy, and pregnancy mortality.⁶

Whereas, according to Pew Research center, 61% of US citizens believe that abortion should be legal in all or most cases.

Whereas, 74% of people aged 18-29 support legal abortion in all cases, one of the age groups that would be most affected by a ban.

Therefore it be resolved, the University of Wisconsin Stevens Point Student Government Association supports the access to medical reproductive rights and bodily autonomy for people across our campus, within Wisconsin, and across the United States.

Therefore it be further resolved, we support the passing of federal and state protection for medical reproductive services such as abortion and support the freedom to choose as a human right for people across the country.

Therefore be it further resolved, that the University of Wisconsin Stevens Point calls on state and federal legislators to advocate on behalf of its citizens for their right to legal and accessible abortion services to support gender equality.
